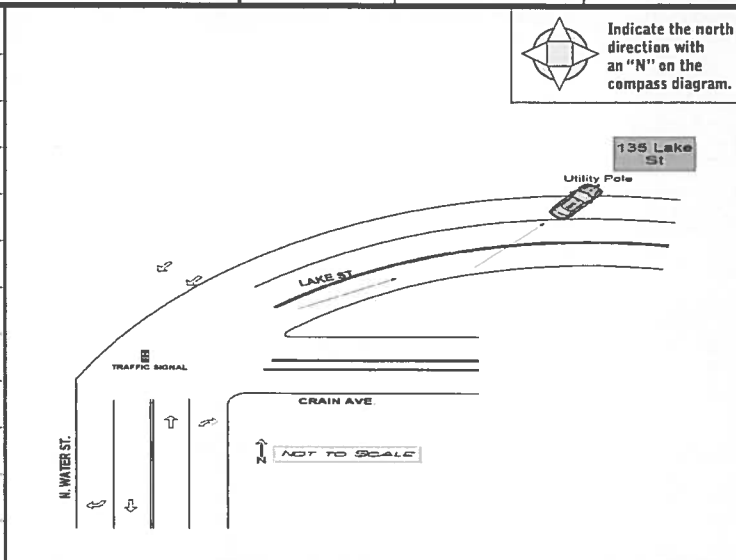

Unit 1 then swerved back into his lane then went left of center again. Unit 1 continued left and went off the roadway on the north side of Lake St and struck a utility pole. The driver of Unit 1 is OVI. The power lines were completely ripped off 133 Lake St and partially ripped off 135 Lake St.

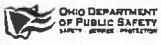
