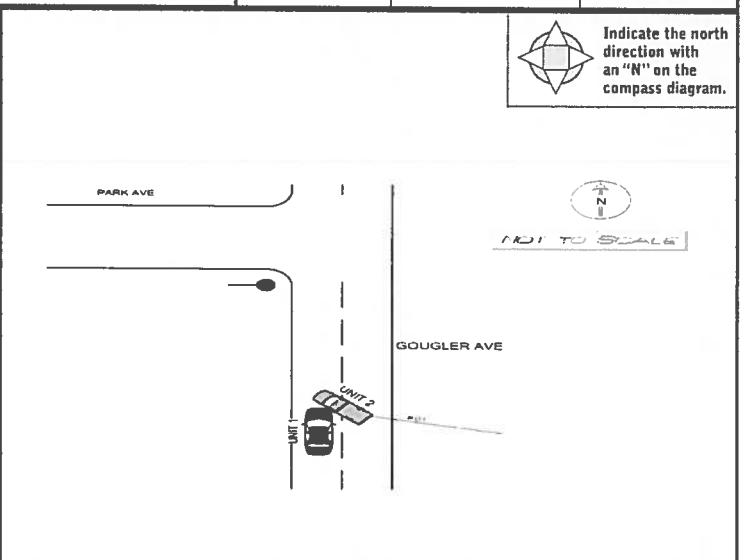

NARRATIVE

Both Units 1 and 2 were traveling from south to north on Gougler Ave. Unit 1 was in the left lane, while Unit 2 was in the right lane. The driver of Unit 2 attempted to merge into the right lane and drove directly in the path of Unit 1 which stuck the drivers side of Unit 2.

No injuries were reported and the driver of Unit 2 was issued a citation for marked lanes.

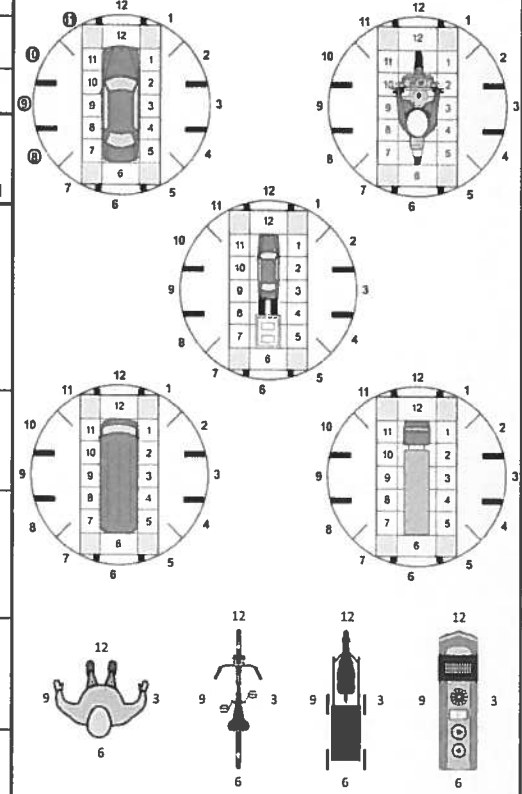
