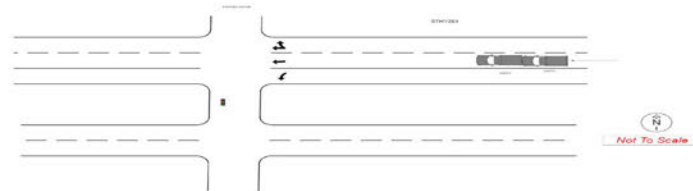
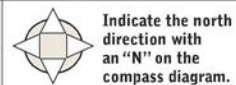

UNIT 2 WAS LOOKING AT THE STOP LIGHT AHEAD OF HIM AND NOT AT UNIT 1 TRAVELING IN FRONT OF HIM. UNIT 2 FAILED TO KEEP AN ASSURED CLEAR DISTANCE AHEAD CAUSING UNIT 2 TO STRIKE UNIT 1 IN THE REAR.

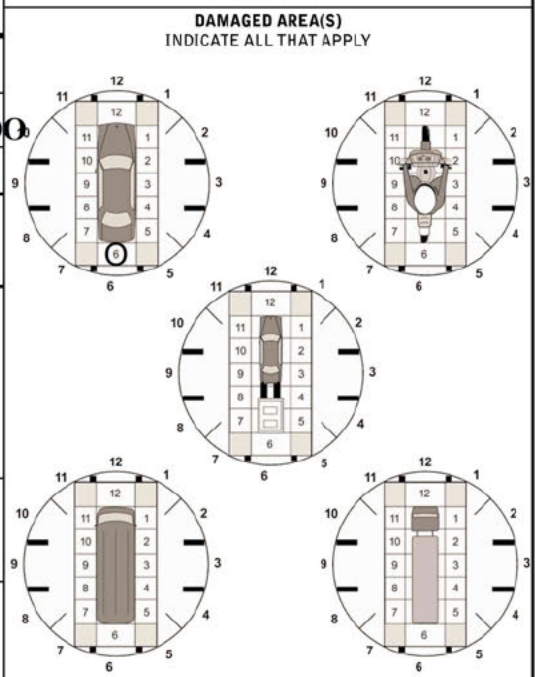

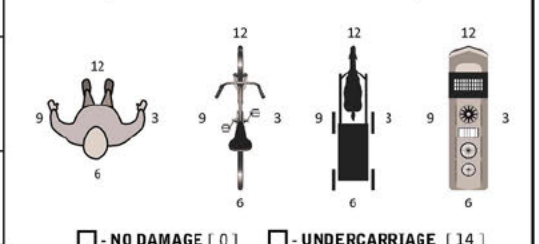

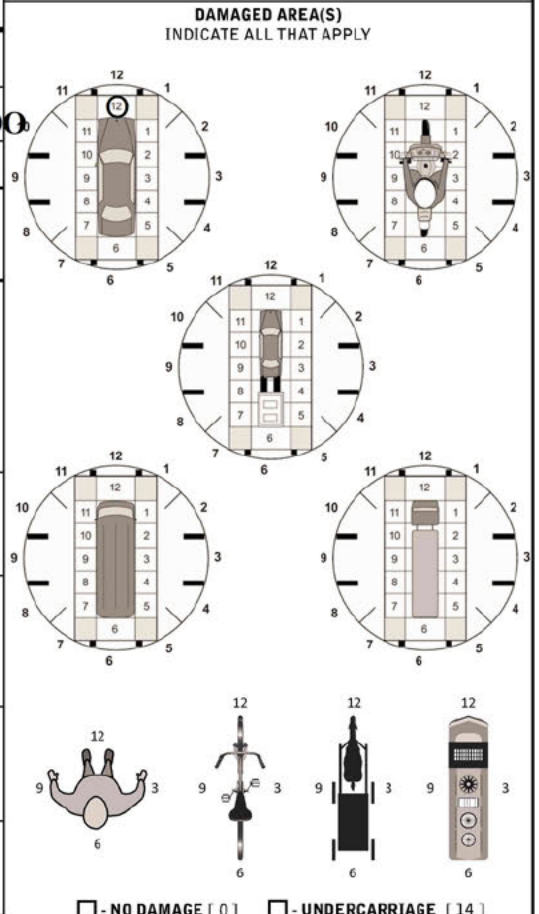
