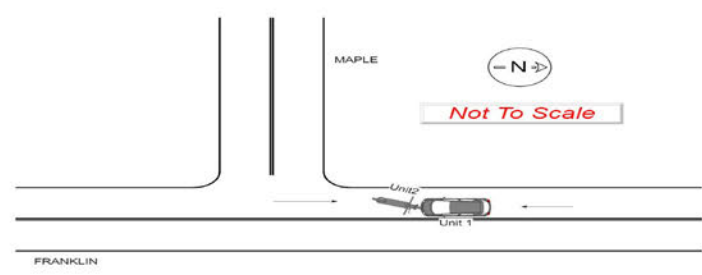
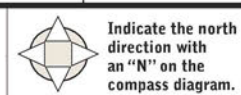

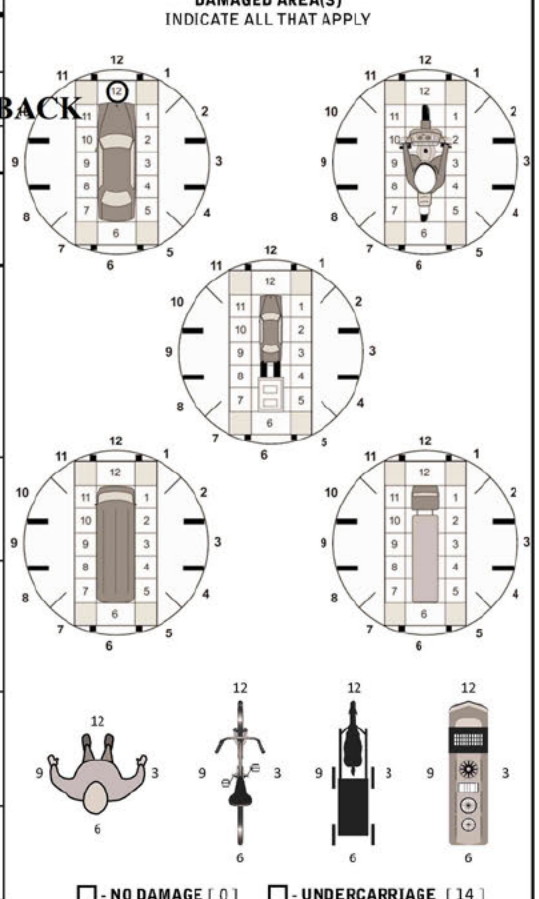

**NON-MOTORIST LOCATION AT IMPACT**

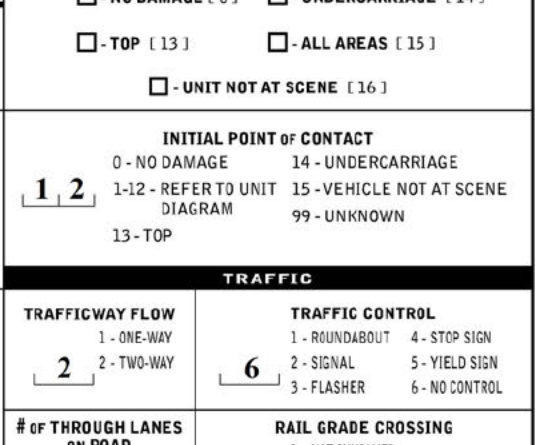

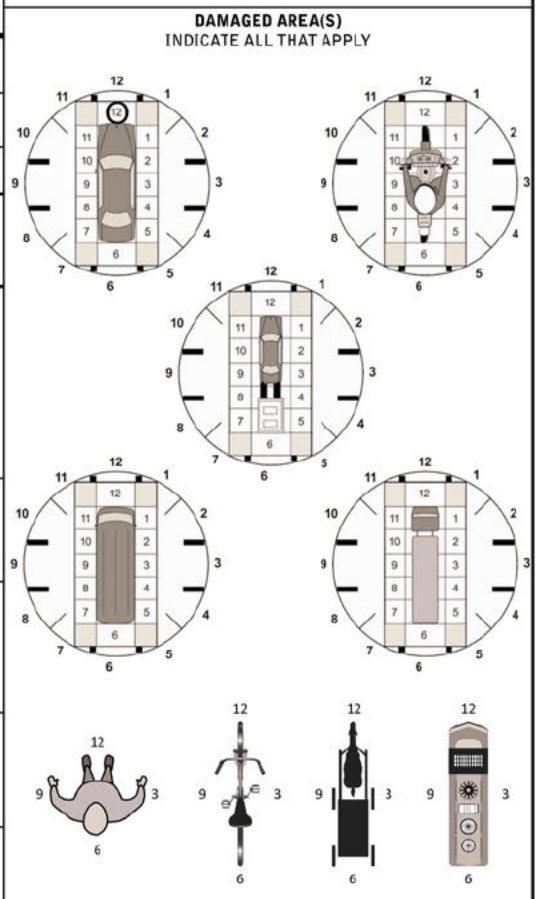
