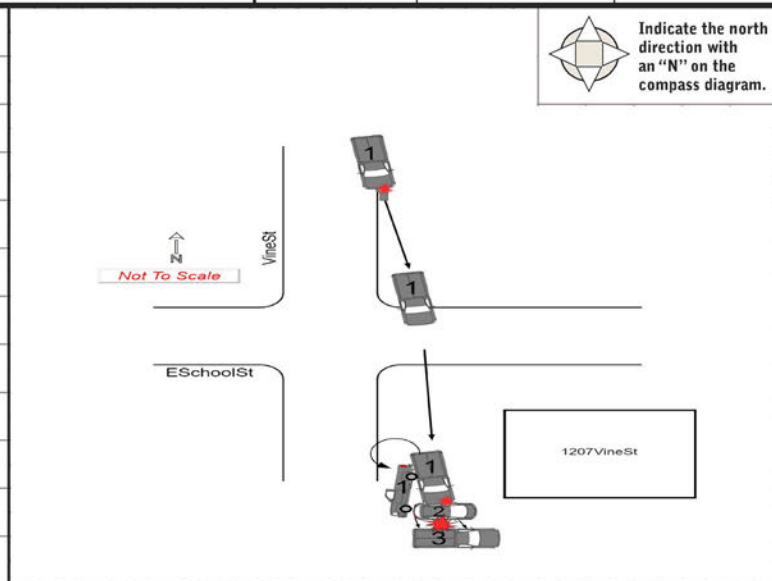

NARRATIVE
Unit 1 was traveling southbound on Vine St passing Elm St. Unit 1 operator passed out at the wheel and ran off the road to the left, striking the curb. Unit 1 continued southbound over the curb strip striking a trash can. Unit 1 crossed over E School St and continued offroad through the yard of 1207 Vine St before striking Unit 2 in the driver side. This caused Unit 2 to strike unit 3 in the driver side. After striking Unit 2, Unit 1 rolled over on its passenger side.

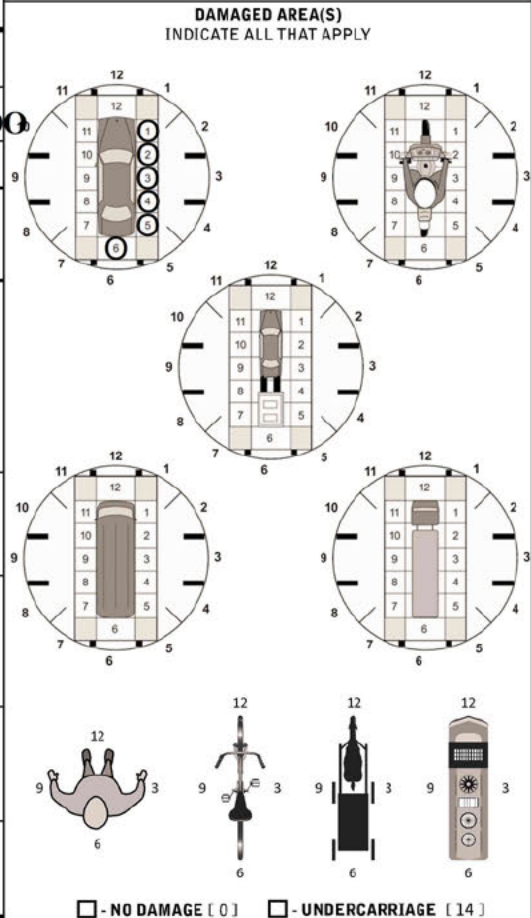

NON-MOTORIST LOCATION AT IMPACT

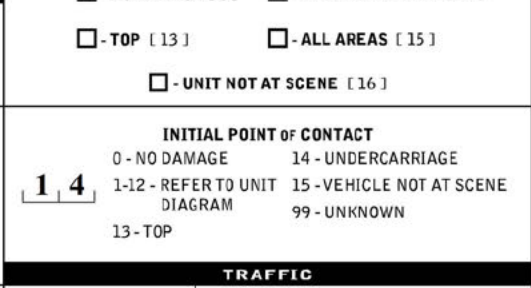

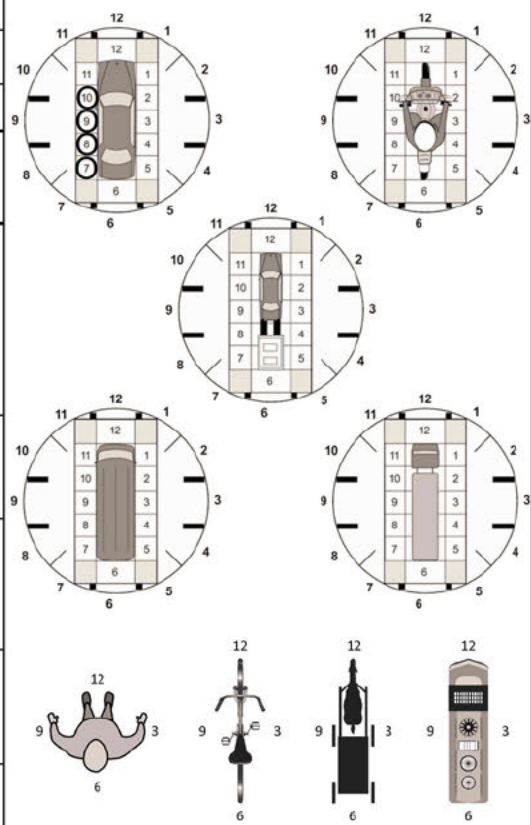
