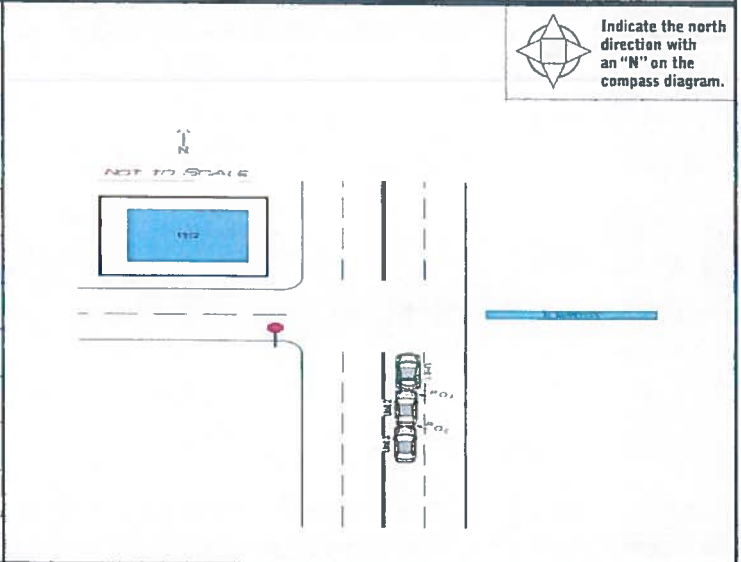

UNIT 3 ATTEMPTED TO SLOW DOWN, BUT SLID ON A PATCH OF ICE AND STRUCK UNIT 2. THIS MOMENTUM CAUSED UNIT 2 TO STRIKE UNIT 1. UNIT 3 CAUSED A 3 CAR ACDA ACCIDENT.**
