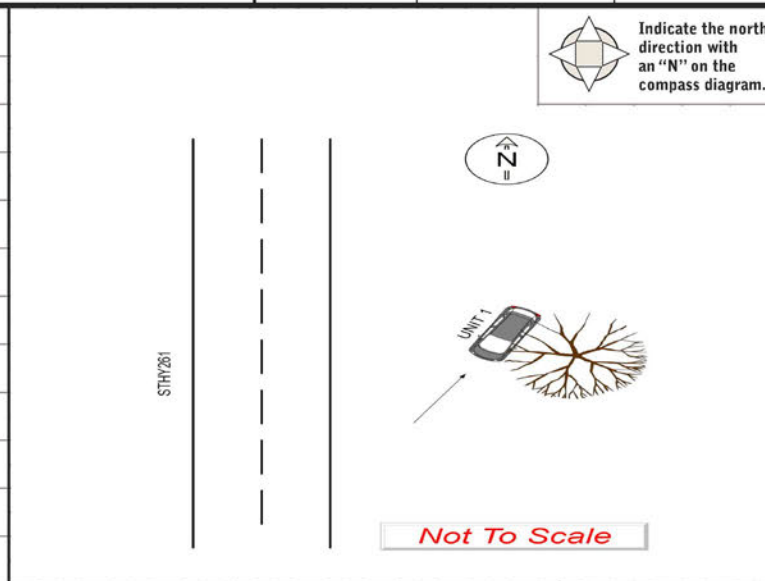

UNIT 1 WAS TRAVELING EB ON STHY 261 AND PASSED ME AT A HIGH RATE OF SPEED. I INITIATED MY OVERHEAD LIGHTS AND SIREN AND UNIT 1 CONTINUED TO FLEE AND ELUDE ME. UNIT 1 WENT IN EXCESS OF 85 MPH IN A 55 MPH ZONE TO FLEE. UNIT 1 THEN RAN OFF ROAD RIGHT AND LOST CONTROL OF THEIR VEHICLE. UNIT 1 THEN SPUN OUT AND CAME TO A REST IN THE TREE LINE OFF THE RIGHT SIDE OF THE ROAD. UNIT 1 WAS CITED FOR RECKLESS OPERATION AND

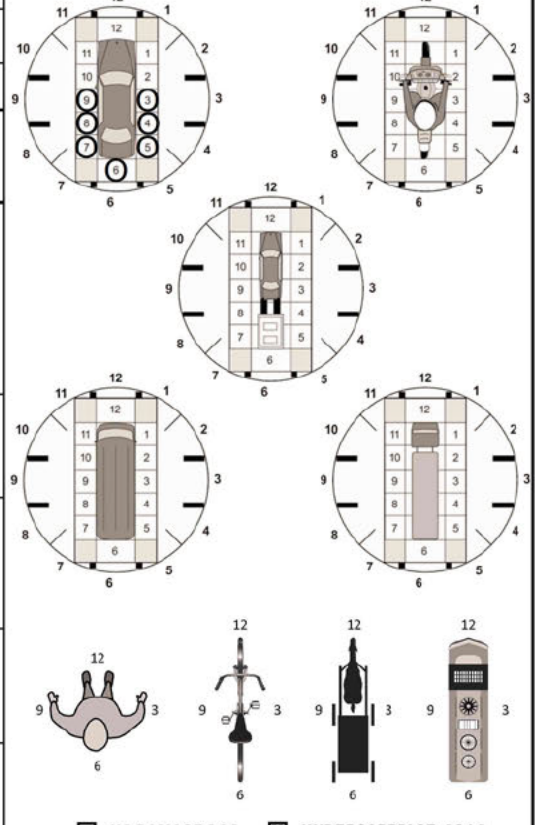
