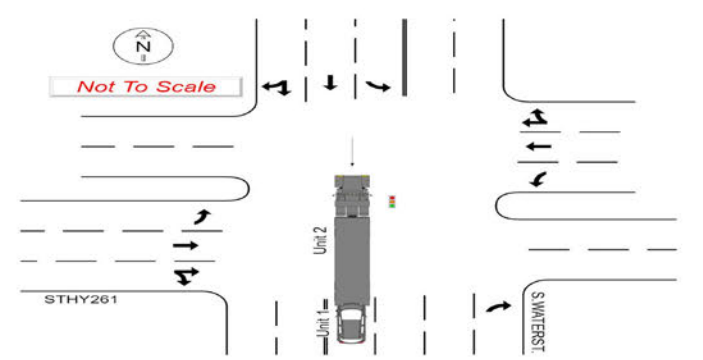
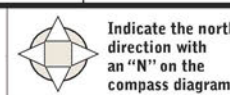

UNIT 2 WAS HEADING NORTHBOUND IN THE LEFT HAND TURNING LANE ON S. WATER ST. TURNING ONTO STHY 261. UNIT 1 WAS BEHIND UNIT 2 IN THE SAME LANE. UNIT 2 BEGAN PULLING INTO THE INTERSECTION BEFORE REVERSING AND STRIKING UNIT 1. UNIT 2 BEGAN PULLING INTO THE INTERSECTION A SECOND TIME BEFORE REVERSING INTO UNIT 1 STRIKING IT AGAIN. UNIT 2 PROCEEDED TO DRIVE THROUGH THE INTERSECTION MAKING A LEFT

The light was green so the semi truck in front of me pulled out into the intersection under the stop light. The driver apparently decided he didn't have enough time to turn and reversed back into the lane colliding with the front of my vehicle while I layed on the horn. The semi then pulled forward a few feet and I reversed as much as I could with a line of traffic behind me, and the semi reversed a second time while me and a vehicle in the next lane over (left hand/straight lane) layed on our horns. The semi then took off running the red light, turning onto 261. I followed the semi down 261 to the intersection of Mogadore road & 261 and took a picture of his license plates & trailer number ~~at the~~ while he was stopped at a red light with vehicles in front of him. The semi then turned left onto Mogadore road, I followed and called Kent Police Department's Non-Emergency number where the dispatcher took down my information and told me to file a report after I left work at 11PM. While on break, I called Mike's Place to see if they have anything on camera.
