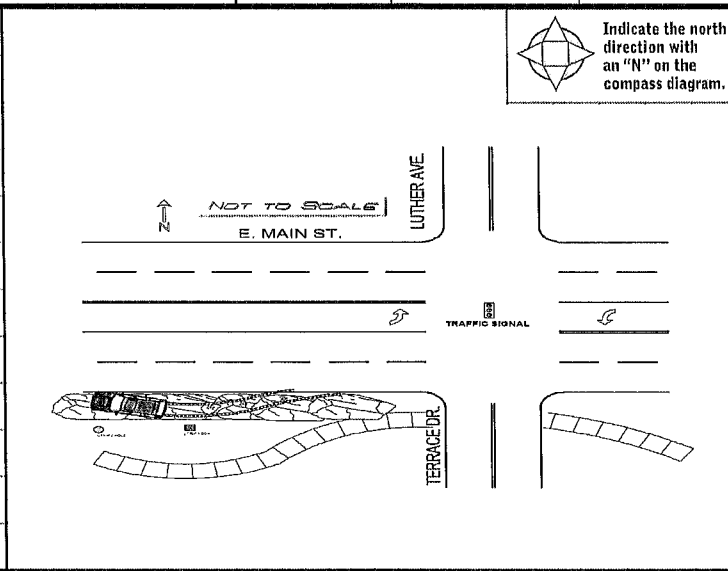

NARRATIVE

UNIT ONE WAS FOUND UNOCCUPIED OFF THE ROADWAY OF E. MAIN ST. THE VEHICLE HAD BEEN TRAVELING WESTBOUND NEAR TERRACE DR. AND RAN OFF THE ROADWAY LEFT, STRIKING A CURB, AND THEN STRIKING A LARGE ICY SNOW BANK WHERE IT CAME TO REST. THE DRIVER WAS IDENTIFIED AFTER FLEEING THE SCENE DURING INVESTIGATION. OVI SUSPECTED, BUT DELAY IN CONTACT AND NOT ABLE TO ESTABLISH INTOXICATION TIMELINE.

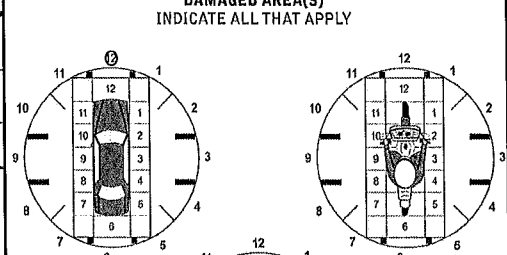

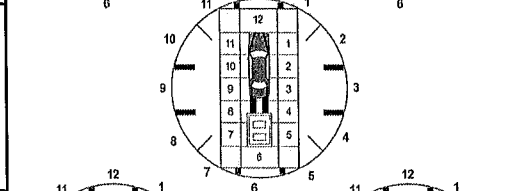

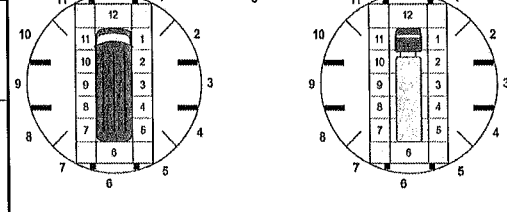


WAS VEHICLE OPERATING IN AUTONOMOUS MODE WHEN CRASH OCCURRED? **2**

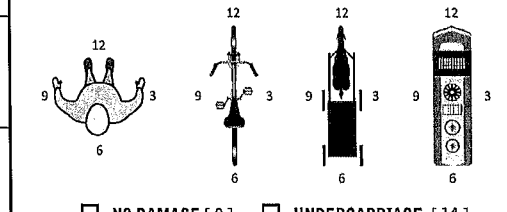
