


Unit One was stopped at a marked pedestrian crosswalk, yielding to a pedestrian. Unit Two was coming to a slow stop behind Unit One. Unit Three was following Unit Two too closely and was unable to stop in time, striking the rear of Unit Two. The impact pushed Unit Two forward into the rear of Unit One.




