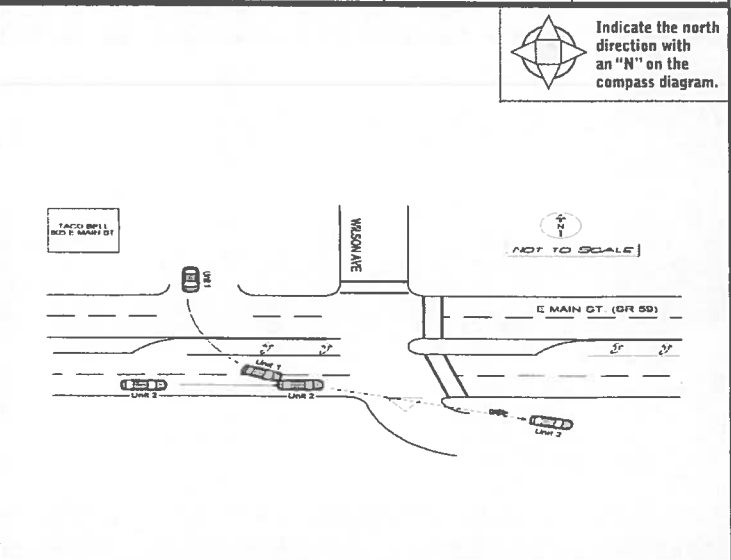

NARRATIVE

Unit 2 was traveling eastbound in the outside lane on E Main St. Unit 1 turned left onto E Main St. from an unknown location (possibly Taco Bell) and entered into the outside lane, striking Unit 2 in the rear left corner. As a result, the driver of Unit 2 lost control of his vehicle and drove off the right side of the road, striking a fire hydrant, and coming to a rest in the R-16 parking lot. Unit 1 left the scene of the accident. The driver of Unit 2 could only describe Unit 1 as a white vehicle. No other details for Unit 1 were known. The fire

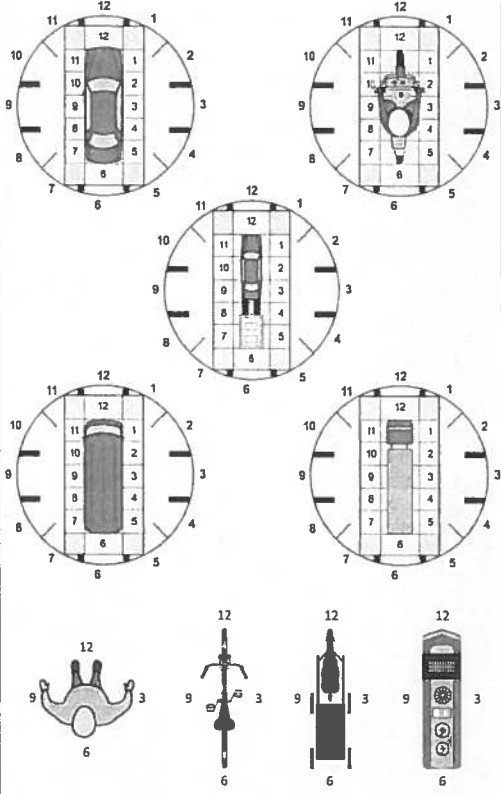
