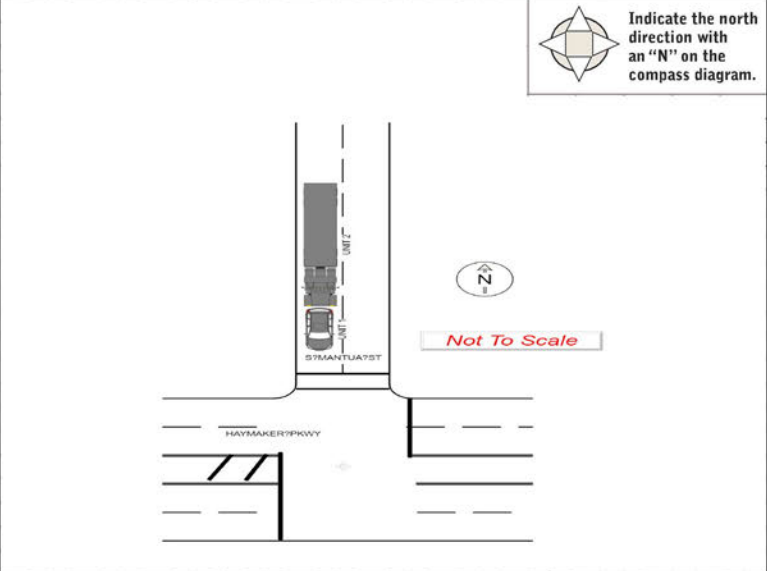

THE DRIVER OF UNIT 1 STATED SHE HAD MULTIPLE VEHICLE LENGTHS BETWEEN HER VEHICLE AND UNIT 2. UNIT 1 STATED UNIT 2 STRUCK HER FROM BEHIND. THERE WERE SMALL SCRATCHES ON THE REAR OF UNIT 1 BUT IT**

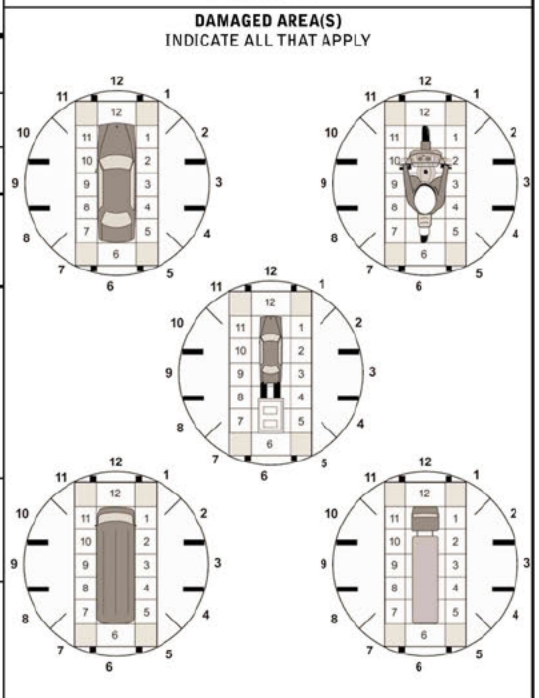

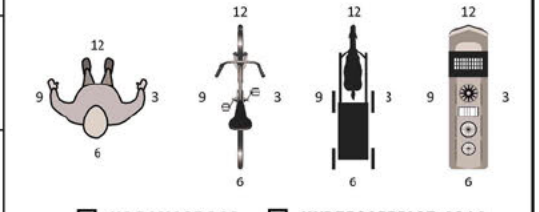
