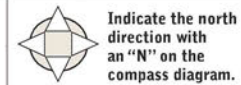

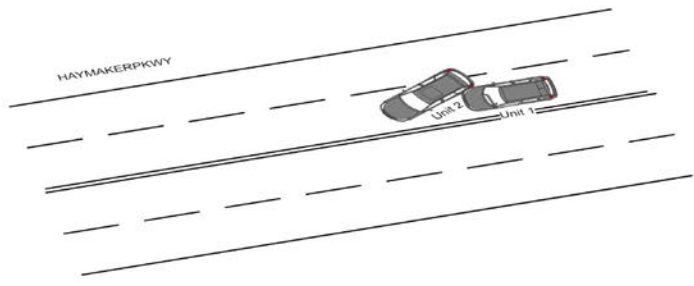

UNIT 1 WAS TRAVELING WEST ON HAYMAKER PKWY IN THE CENTER LANE. UNIT 2 TRAVELED WEST IN THE CURB LANE. UNIT 2 MERGED INTO THE CENTER LANE IMPROPERLY. UNIT 1 HAD TO SWERVE THEIR VEHICLE OVER THE DOUBLE YELLOW TO AVOID UNIT 2 HITTING THEM. UNIT 1 THEN HAD TO SWERVE BACK BUT UNIT 2 WAS STILL IN THEIR LANE OF TRAVEL CAUSING UNIT 1 TO HIT UNIT 2. UNIT 2 LEFT THE SCENE BUT WAS LATER IDENTIFIED.

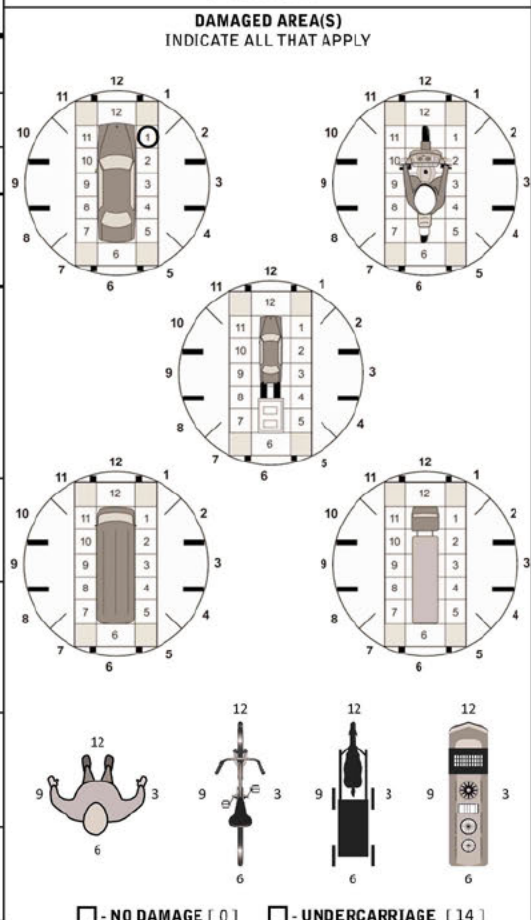

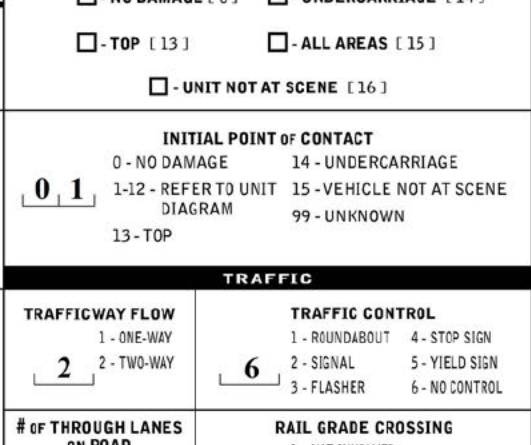
