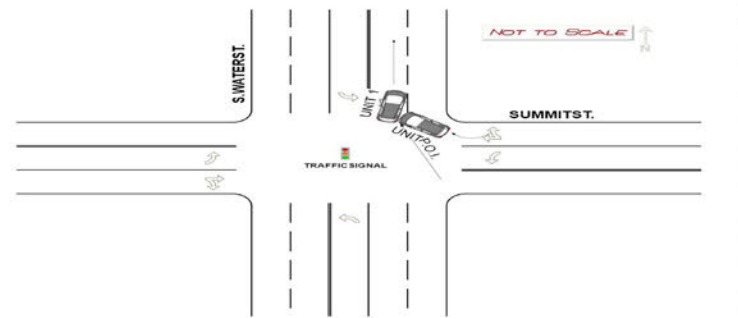
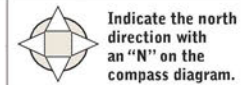

Due to the fact that neither party reported the accident at the time of the crash, I was unable to determine who was at fault or any exact details of the incident.**
