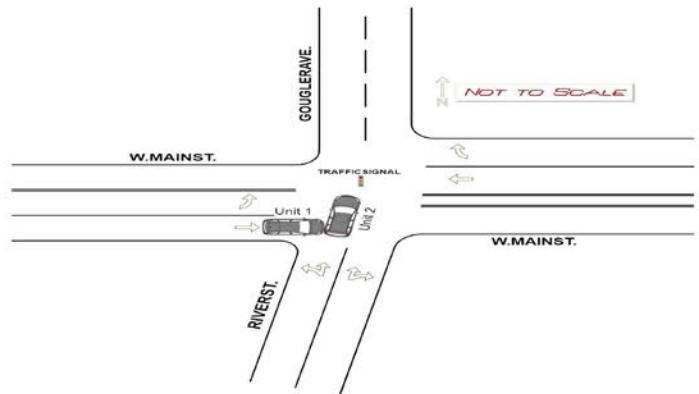
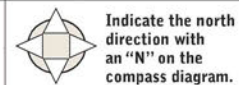

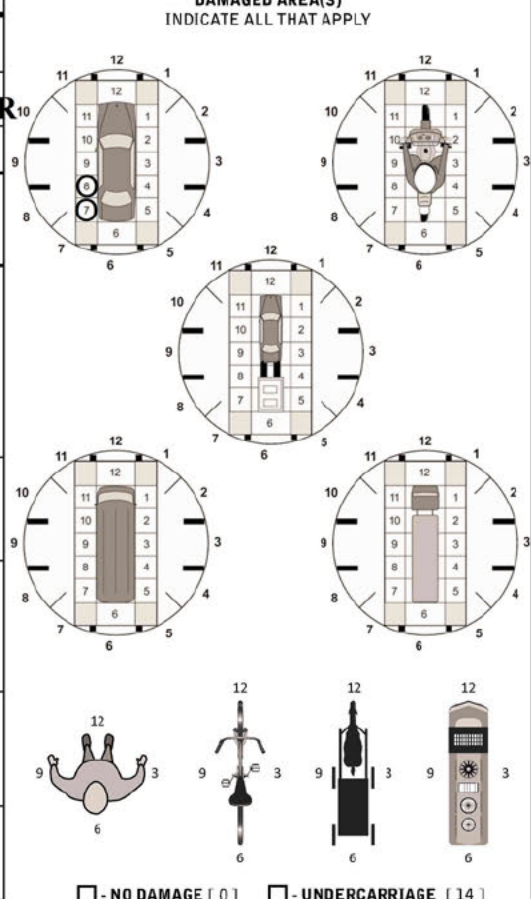

were not injured beyond bumps and scrapes. Two of the
passengers, along with myself, can verify our light was
green. After checking to make sure my passengers
were OK, I checked on the driver of the other
vehicle. He seemed more hurt, holding his head,
all air bags of his vehicle deployed. I helped him
to the curb. We called PD and he did too.
And here we are.
