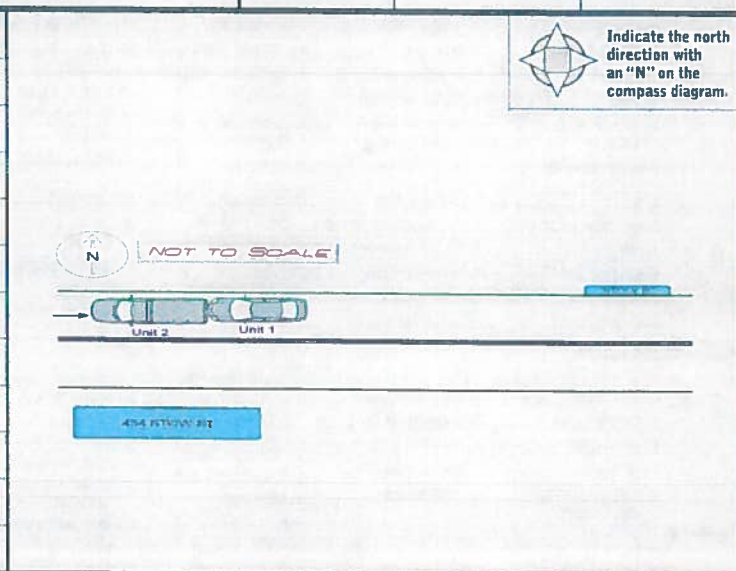

UNIT 2 FAILED TO OBSERVE UNIT 1 BEHIND HIS VEHICLE AND STRUCK THE FRONT OF UNIT 1. UNIT 2 HAD NO DAMAGE ONLY UNIT 1. UNIT 2 CAUSED A 2 VEHICLE MINOR PROERTY DAMAGE ONLY CRASH.
