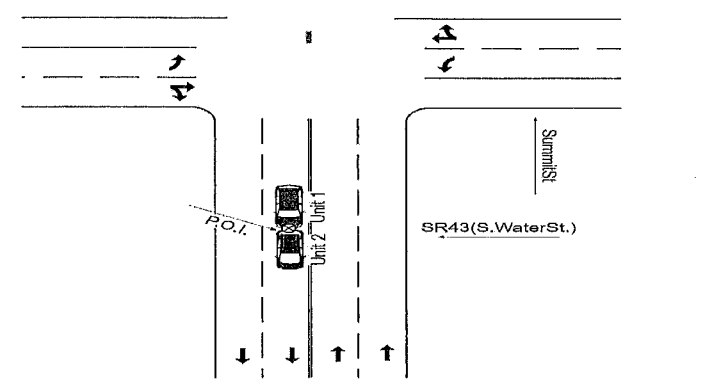
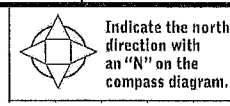

Unit 2 was stopped for traffic facing south on S. Water St. (SR43) approximately 150 ft. south of Summit St. Unit 1 was driving south on S. Water St. Both unit 1 and unit 2 were in the middle center lane. Unit 1 failed to reduce speed to avoid a collision and struck the rear of unit 2.
