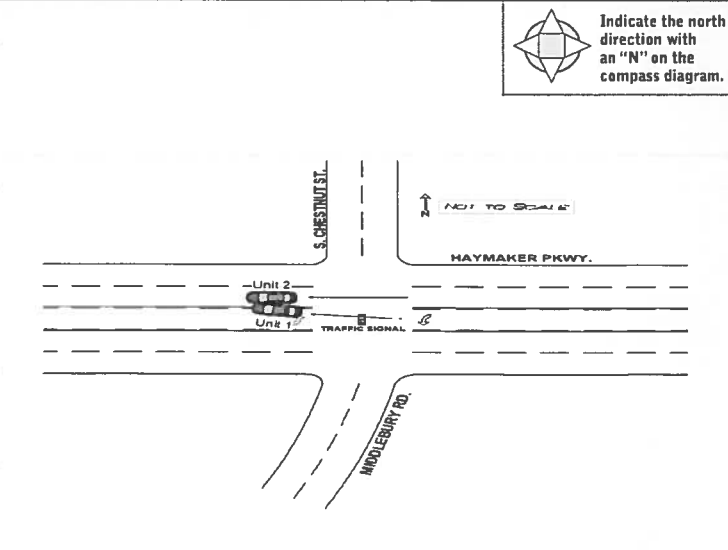

UNIT 1 WAS TRAVELLING WESTBOUND ON HAYMAKER PKWY. AND WAS STOPPED AT THE RED LIGHT IN THE LEFT TURN LANE ONLY. UNIT 2 WAS TRAVELLING WESTBOUND AND WAS STOPPED IN THE LEFT HAND LANE AT THE RED LIGHT. WHEN THE LIGHT TURNED GREEN, UNIT 1 DID NOT MAKE A LEFT TURN AND CONTINUED STRAIGHT INTO THE ONCOMING LANE OF TRAVEL. UNIT 1 ATTEMPTED TO MERGE INTO THE LEFT LANE OF TRAVEL AND SIDE SWIPED UNIT 2.

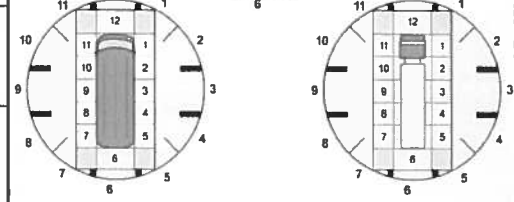


WAS VEHICLE OPERATING IN AUTONOMOUS MODE WHEN CRASH OCCURRED? 2

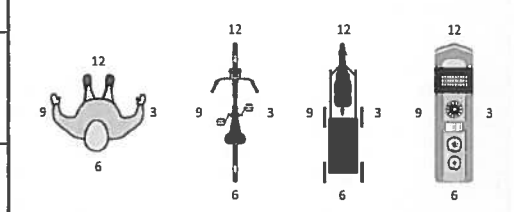
