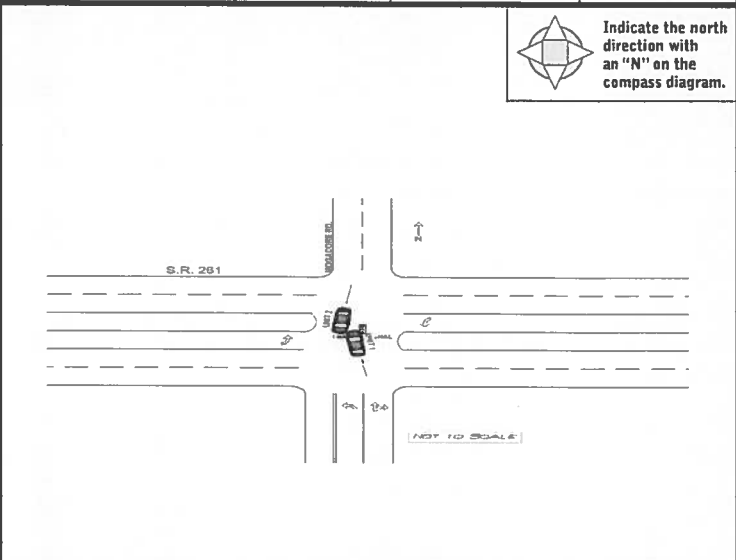

THE DRIVER OF UNIT 1 WAS THEN FOUND TO BE UNDER THE INFLUENCE OF ALCOHOL. THE DRIVER TESTED POORLY ON SFST'S. DRIVER THEN REFUSED THE BAC
