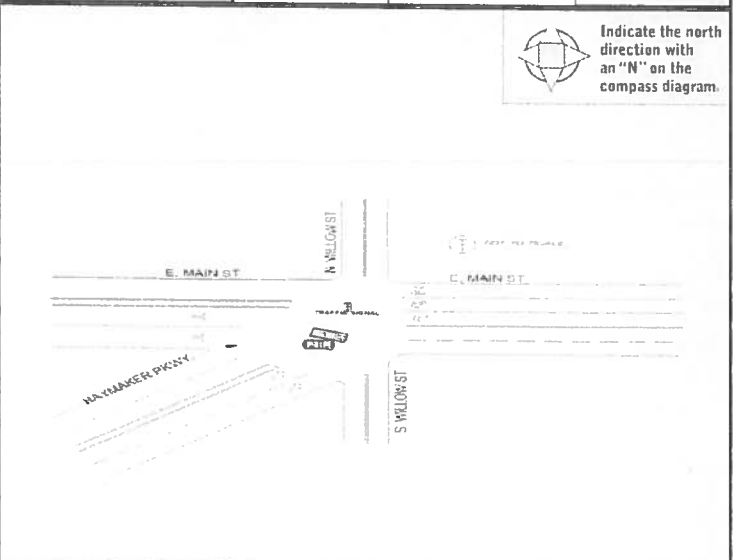

IN THE CURB LANE THROUGH THE INTERSECTION AT WILLOW ST. WHEN UNIT 2 WAS SIDESWIPE BY UNIT 1 AFTER UNIT 1 ATTEMPTED TO MAKE AN UNSAFE LANE CHANGE. UNIT 1 THEN LEFT THE SCENE WITHOUT STOPPING. DRIVER OF UNIT 2 HAD DASH CAMERA FOOTAGE OF THE CRASH WHICH SHOWED UNIT 1 LICENSE PLATE. OWNER OF UNIT 1 WAS CONTACTED WHO STATED HIS DAUGHTER WAS DRIVING AND THEY THEN CAME TO THE POLICE DEPARTMENT TO FOLLOW UP ON 04-28-21.
