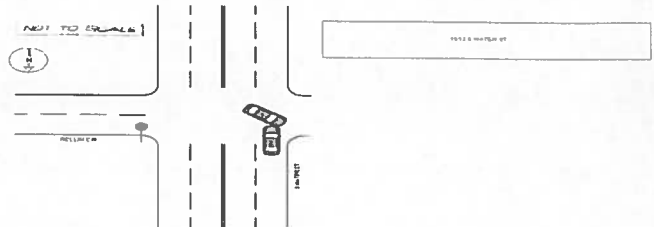
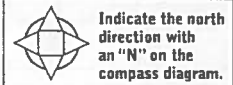

UNIT 1 FAILED TO YIELD TO ONCOMING TRAFFIC (UNIT 2) AND COLLIDED WITH UNIT 2 WHILE TURNING. BOTH OCCUPANTS OF UNIT 1 CLAIMED POSSIBLE INJURY BUT DENIED TREATMENT AND STATED THEY WOULD GO TO UH KENT THEMSELVES
