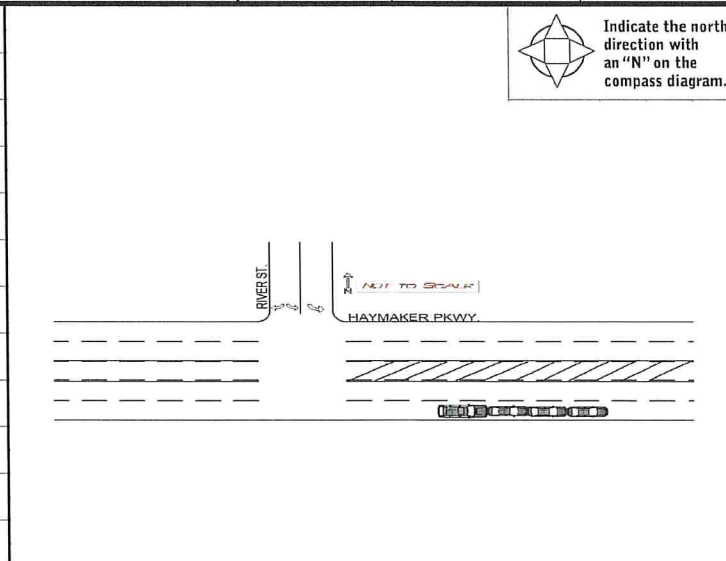

UNIT 4 AND UNIT 3 WERE STOPPED IN TRAFFIC ON HAYMAKER PKWY HEADED EAST BOUND. UNIT 2 WAS SLOWING TO STOP APPROXIMATELY 15 FEET BEHIND UNIT 3. UNIT 1 FAILED TO MAINTAIN ASSURED AND CLEAR DISTANCE AHEAD AND REAR ENDED UNIT 2 CAUSING UNIT 2 TO STRIKE UNIT 3. UNIT 3 WAS THEN PUSHED INTO UNIT 4. ALL VEHICLES WERE DAMAGED.
