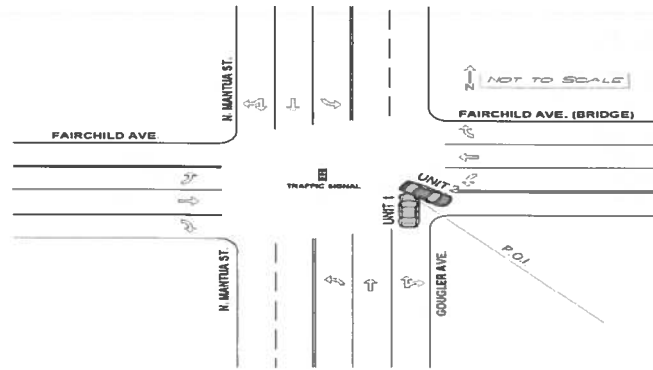
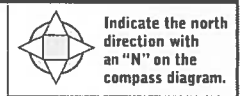

NARRATIVE

Unit 1 was traveling from south to north on N Mantua St. Unit 2 was turning from north to west on N Mantua St onto Fairchild Ave. While doing so, Unit 2 turned directly in front of Unit 1 causing them to strike the passenger side of Unit 2.
