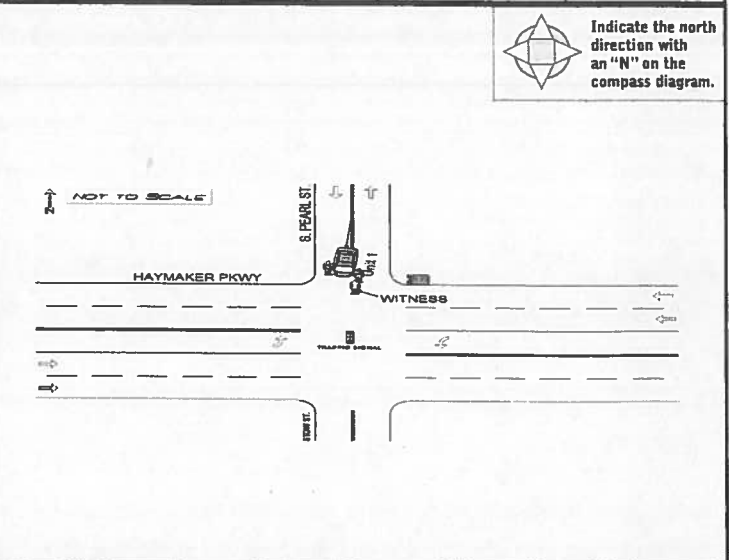

UNIT 1 WAS TRAVELING S/B ON S. PEARL ST. NEAR HAYMAKER PKWY. BOTH SIDES OF THE STREET WERE BLOCKED BY CONSTRUCTION VEHICLES WITH ACTIVATED WHITE AND YELLOW FLASHING WARNING LIGHTS. THE INTERSECTION HAD SEVERAL CONSTRUCTION VEHICLE IN OR NEAR IT. THIS CONTINUED ACTION LEFT 2 CONSTRUCTION WORKERS (UNIT 2 &3) STRUCK BY UNIT 1 AND UNIT 1'S RIGHT SIDE FRONT PASSENGER DOOR WINDOW SHATTERED. UNIT 1 FLED THE SCENE AFTER CONTINUING INTO THE INTERSECTION ON A RED TRAFFIC SIGNAL. UNIT 2 & 3 REPORTED NO INJURIES. UNIT 1 CAUSED A 1 VEHICLE, 2 PEDESTRIAN CRASH.
