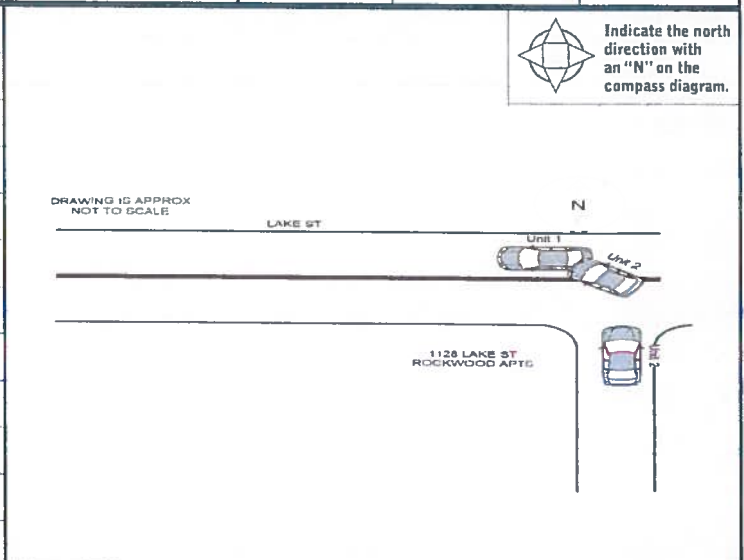

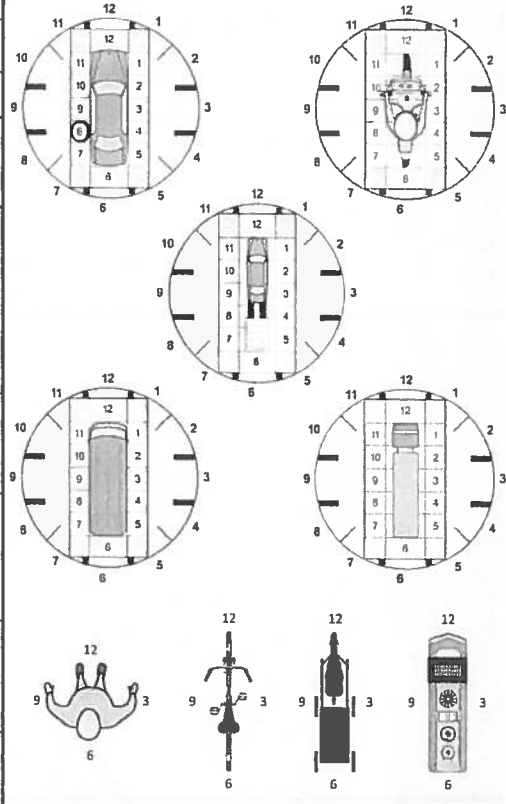

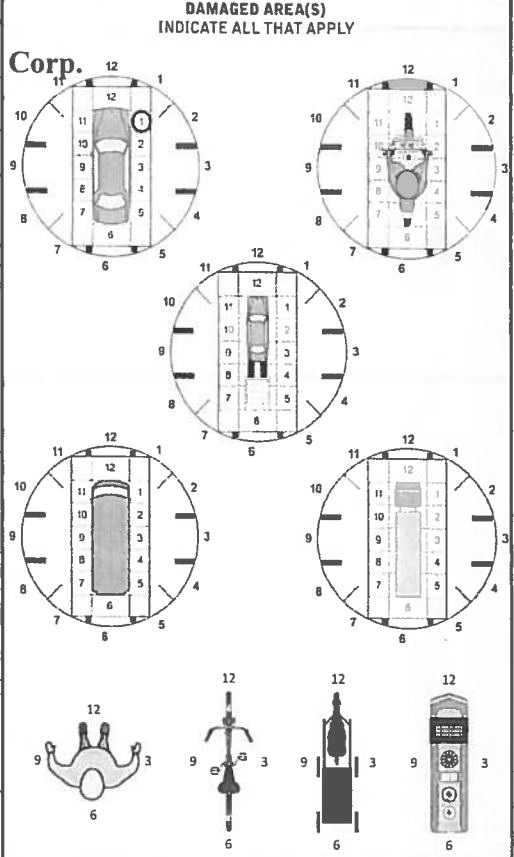

ON THIS DATE AT APPROXIMATELY 2210 HOURS, I RESPONDED TO 1129 LAKE ST. FOR A TWO CAR ACCIDENT. UPON MY ARRIVAL, THE ADDRESS WAS FOUND TO BE ROCKWOOD APTS., 1128 LAKE ST. BOTH VEHICLES WERE STILL IN THE ROAD FACING WEST BOUND IN THE EAST BOUND LANE. I ASKED BOTH DRIVERS IF THEY WERE INJURED AND THEY SAID NO. I THEN ASKED THE DRIVERS IF THEY WERE ABLE TO MOVE THEIR VEHICLES, THEY WERE, AND WE ALL MOVED INTO THE PARKING LOT OF 1128 LAKE ST. TO CLEAR THE ROADWAY.

UNIT 1 STATED THAT HE WAS WEST BOUND ON LAKE ST. AND UNIT 2 TURNED LEFT OUT OF ROCKWOOD, STRIKING HIM IN THE DRIVER'S SIDE REAR OF HIS VEHICLE. UNIT 1 STATED HIS BACK HURT BUT HE DECLINED MEDICAL ATTENTION AND SAID HE MIGHT GO TO THE DOCTOR LATER. I ADVISED UNIT 1 TO CALL AND UPDATE ME IF HE DOES GO TO THE DOCTOR.

UNIT 2 STATED HE WAS TURNING LEFT OUT OF ROCKWOOD APTS. AND THAT HE LOOKED IN BOTH DIRECTIONS BEFORE DOING SO. UNIT 2 TURNED LEFT AND STRUCK UNIT 1, WHO HAD THE RIGHT OF WAY AND WAS TRAVELING WEST BOUND ON LAKE ST. UNIT 2 STATED THAT UNIT 1 MUST HAVE BEEN SPEEDING BECAUSE HE LOOKED BEFORE HE TURNED AND DIDN'T SEE HIM.

DUE TO WHERE THE DAMAGE IS LOCATED ON BOTH VEHICLES, UNIT 1 WAS ALMOST PAST UNIT 2 BEFORE UNIT 2 TURNED INTO HIM. UNIT 2 WAS CITED FOR RIGHT OF WAY UPON ENTERING THE ROADWAY. BOTH VEHICLES WERE ABLE TO BE DRIVEN AWAY.
