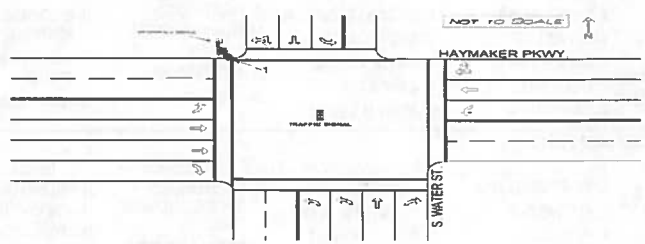
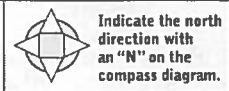

NARRATIVE  
**UNIT 1 WAS TRAVELING NORTHBOUND ON S WATER ST NEGOTIATING A LEFT TURN ONTO HAYMAKER PKWY. WHILE TURNING, UNIT 1 LOST CONTROL OF THE MOTORCYCLE, HIT THE CURB, AND RAN OFF THE ROAD TO THE RIGHT. UNIT 1 THEN STRUCK A LIGHTED CROSSWALK SIGNAL POST, THE MOTORCYCLE WAS LAID OVER, AND THE DRIVER FELL OFF OF THE MOTORCYCLE. THE DRIVER DECLINED MEDICAL TREATMENT AND DID NOT HAVE ANY VISIBLE INJURIES.**
