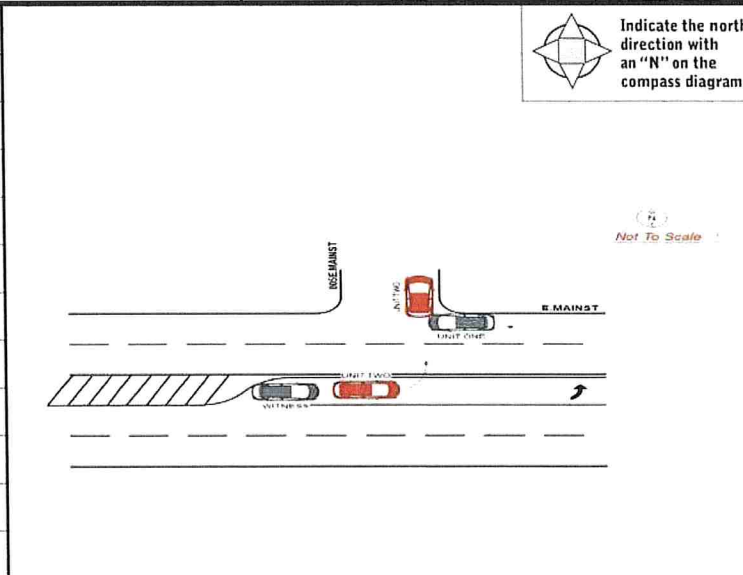

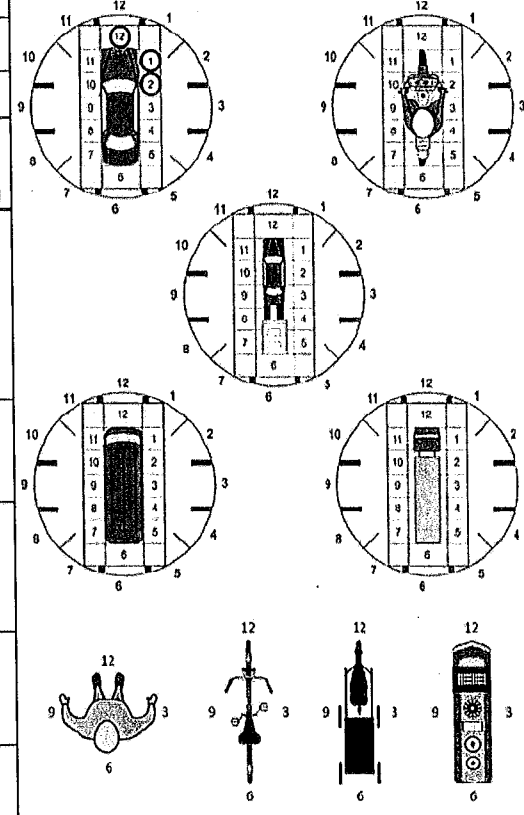

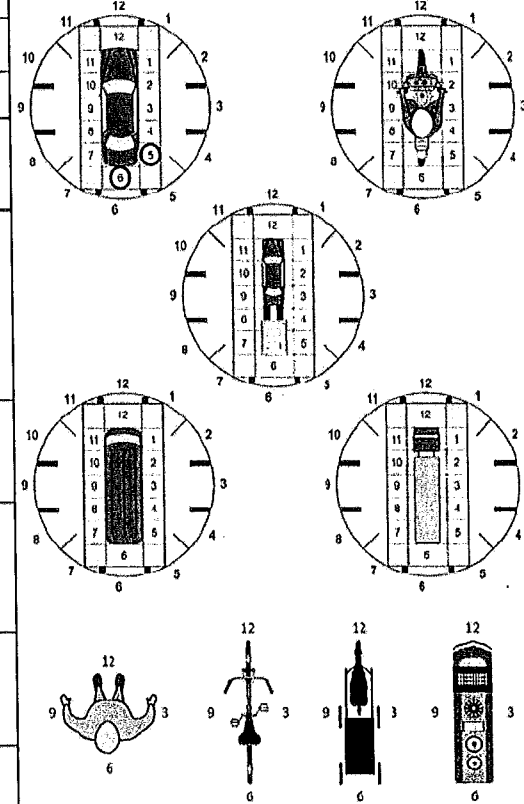

We were at that moment in the turning lane (to go left into the lot) and Abby Mahan was the next car ahead of us, except she was already pulled into the lot of taco bell. I look ahead and see a smaller sedan type car flying down the road (taco bell was going to be on their right side.) I guessed they were going about 50-60 mph from my best judgement in a 35mph zone. a different car goes to slowly turn right out of the taco bell lot and proceeds to pull out. The car that was flying then rips into Abby's rear of her car, making her bumper fly about 50 feet into taco bells yard. the driver then rode up on a curb after taco bell I believe and slowed down closer to the dunk-in. I thought they would stop but they started driving and just left. my boyfriend pulled next to abby's car, and then in front of her's once we knew she was okay and police were on their way.
