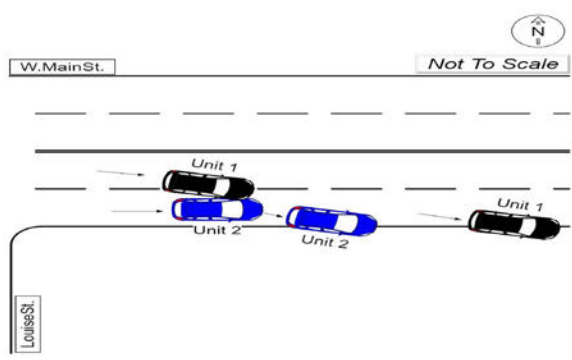
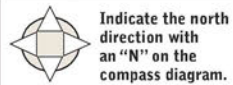

the right lane and struck Unit 2.



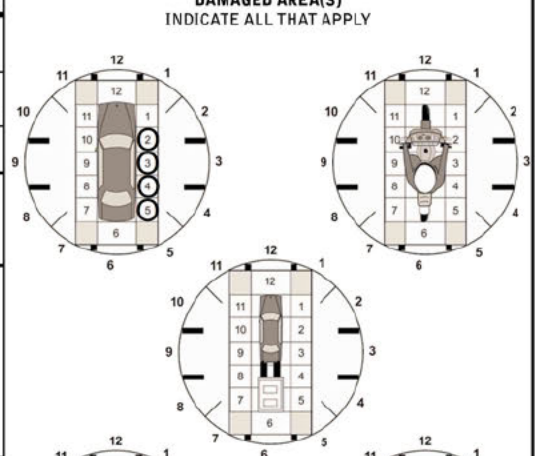

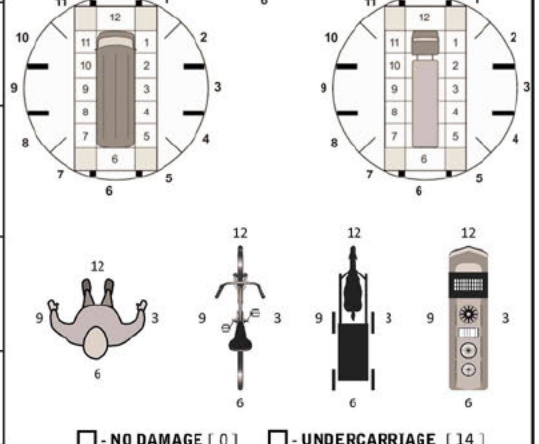

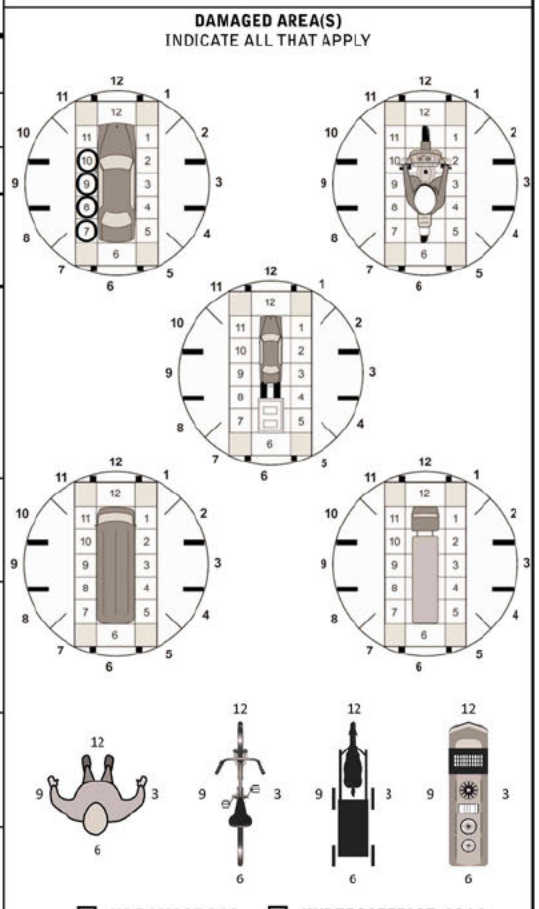
